

Rebate Requirements

PSEG Long Island offers a wide array of incentives and rebates for residential customers to help reduce their energy usage and lower monthly bills. For a limited time, residential customers can receive rebates from PSEG Long Island through the purchase of eligible ENERGY STAR® certified and other selected products and Ducted/ Ductless Air Source Heat Pumps. Please refer to the below guidelines for rebate eligibility requirements:

Requirements for **all** applications:

- Customer must have a valid PSEG Long Island residential account number
- All required documents must be uploaded in appropriate application section
 - Dated sales receipt/paid invoice
 - Must show manufacturer, model number, and price paid
 - Online Purchases require proof of delivery/proof of pickup receipt or the rebate will be denied
- Account service address and installation address on receipt must match to receive rebate (if applicable)
- A PSEG Long Island representative may contact the account holder to schedule an on-site verification of installed equipment
- A PSEG Long Island representative may request photos of the installed equipment and of the nameplate on the equipment. Photos of the nameplate must clearly show the model and serial number of the installed equipment.

Additional Requirements for all **appliance** applications:

- Online rebate application must be completed within 45 days of purchase
- The rebate amount cannot be more than 50% of the retail purchase price paid
- Appliances must be ENERGY STAR or ENERGY STAR Most Efficient 2024 certified where designated

Additional Requirements **for air source heat pump** applications:

- Online rebate application must be completed within 90 days of purchase and installation
 - ***Rebates are limited to every 5 years***
- AHRI Certificate must be provided

The following products are rebated by PSEG Long Island:

- ENERGY STAR Electric Heat Pump Water Heater (1/5 years) * 1 within 5-year period beginning in 2021
- ENERGY STAR Most Efficient 2024 Heat Pump Dryer (1/year)
- ENERGY STAR Electric Dryer (1/year)
- ENERGY STAR Most Efficient 2024 Clothes Washer (1/year)
- Heat Pump Pool Heater (1/5 years) * 1 within 5-year period beginning in 2021
- ENERGY STAR EV Level 2 Rated Smart Charger (1/year)

The following Air Source Heat Pump equipment is rebated by PSEG Long Island:

- Ductless Air Source Heat Pump SEER ≥18 & HSPF ≥8.5 (2 per every 5 years)
- Ducted Air Source Heat Pump SEER ≥15 & HSPF ≥8.5 (2 per every 5 years)
- ENERGY STAR Smart Thermostat – Learning **Thermostat rebate only available if applying for Heat Pump rebate**
- ENERGY STAR Smart Thermostat – Connected **Thermostat rebate only available if applying for Heat Pump rebate**

Cold Climate Air Source Heat Pump Equipment combination must be listed on the NEEP Cold Climate Air Source Heat Pump list found here: https://ashp.neep.org/#!/product_list/

PSEG Long Island Smart Charger Rebate Terms:

- You must be a PSEG Long Island residential customer.
- Account service address and installation address on receipt must match to receive this rebate.
- There is a limit of one rebate per year, per residential account.
- Qualified purchases made as of January 1, 2024 or later are eligible to apply
- Please allow up to 8 weeks for delivery of the rebate check.
- PSEG Long Island is not responsible for any tax liability imposed as a result of rebate payments.
- PSEG Long Island is not responsible for lost or undeliverable mail or email.
- PSEG Long Island reserves the right to use the customer rebate to credit accounts in arrears.
- Electric Vehicle Supply Equipment (EVSE) rated Level 2 chargers must be on the qualified ENERGY STAR list at time of purchase.
- By providing a telephone number and email address, you are giving consent to be contacted at that number about matters that are closely related to the utility service.
